Dear Onondaga Central School District Residents:

I would like to thank the community and staff for all the hard work during the pandemic. With stakeholder's support, we provided PreK-6 students to attend school in-person learning five days per week or remotely with their own grade-level teacher. At the Jr./Sr. High School, students participated in a hybrid model, and this afforded



students to attend school two, four, or five days per week based on the student and family needs. This transition to four or five days per week came quickly as we assessed the needs of students and families following the DOH and CDC quidance.

On May 18, 2021, Onondaga Central School District residents will have an opportunity to vote on a \$23,190,109 proposed budget for the 2021-2022 school year budget. The Onondaga Central School Community prides itself on challenging students to their maximum potential and preparing students to be contributing citizens for life.

Listed below are budget details and some of the priorities this budget includes to help continue the community's success:

- School Safety & Security
- Commitment to Small Class Size
- ELL/ENL Staffing Support
- Special Education & Alternative Education Programs
- Academic Intervention Services (AIS)
- Maintain all Current Educational Programs

- Maintain Facilities
- Annual Computer Replacement Plan
- Ability to Handle Fiscal Challenges
- Annual School Bus Replacements
- Account for Federal/State Mandates

The budget calls for a 2.6% increase in spending from the 2020-2021 school year and carries a 1.99% tax levy increase. Under the NYS Tax cap law, the district has a levy threshold limit of 2.72%. The tax levy increase of 1.99% has an estimated increase for the cost to landowners of the Town of Onondaga of 55 cents per \$1000 of assessed value.

The \$590,724 increase in the general fund budget is mostly due to increases in contractual obligations, resources to maintain our educational programs, and health insurance expenses. In summary, we are proposing a school budget in the amount of \$23,190,109 to be voted upon on May 18, 2021.

Elections and voting will be in-person on May 18, 2021, from 7:00 a.m. - 9:00 p.m. at Rockwell Elementary School's Gymnasium, located at 208 Rockwell Road, Nedrow, NY 13120, and at the Jr./Sr. High School's Cafeteria Lobby, located at 4479 South Onondaga Road, Nedrow, NY 13120. Absentee ballots can be requested. If the absentee ballot is to be mailed to the voter, the application must be submitted at least seven days prior to the vote. An absentee ballot may be picked up at OCSD District Office, 4466 South Onondaga Road, Nedrow, NY 13120 by the voter in person; applications will be accepted until May 17, 2021. Absentee ballots must be received by the District Clerk no later than 5:00 p.m. on May 18, 2021.

The chart to the right is a comparison of our actual 2008-2009 through 2020-2021 school budget information and the proposed 2021-2022 school budget data. In August, we will receive the updated property assessment figures from the four towns in our district. As evidenced by the chart to the right, you can see there were many years with a zero percent increase to taxpayers making an overall average of .41% for the past fourteen years.

This year's State Budget also included allocations for the Federally funded American Rescue Plan Act (ARAP). Onondaga CSD is estimated to receive \$2 million dollars in the form of a learning loss grant, with specific allowable expenses. Since there are restrictions on this grant, the district is required to apply for this money and therefore it cannot be accounted for in the general annual budget. Also, schools cannot receive funding until the educational grant is approved by the NYS Education Department and the application process is currently not available.

Thank you for your continued support of the Onondaga Central School District's budget development process. We certainly appreciate the investment that each of you makes in the education and future of all OCS students. Please be safe and well as we all manage through the pandemic.

What a different kind of school year it has been! I am so proud of the staff at Rockwell School for working so hard over the summer to plan for the re-opening of the school during this pandemic. The teachers, teacher assistants, nurse, custodians, secretaries and all the staff have gone above and beyond to keep the school open with all the health protocols we have implemented, followed and continue to tweak as needed. We are offering bi-weekly COVID testing to ensure the safety of all. Desks, doorknobs, railings, sinks, and phones are all sanitized twice a day. Nightly cleaning protocols have improved to meet the COVID demands. Desks are six feet apart, students' belongings are in bins and tiger paws are on the floor to keep us safely apart when walking in the hallways. Recess has been broken down to three different locations for smaller group sizes. The children have adjusted well to the new protocols and now these changes are the new normal.

The children at Rockwell School have been so fortunate to attend school five days a week with little disruption since September. Academics are still our priority. Closing school last spring has affected the children's learning, but the teachers have worked doubly hard to close that achievement gap. Our AIS teachers and librarian are now classroom teachers doing an amazing job to meet the needs of the students.

Rockwell has offered remote learning at Pre-K through second grade. The teachers have worked hard creating materials and work packets that are sent home to go along with their Google Classroom lessons. The students and teachers have created nice classroom communities interacting with each other as if they were in person.

COVID may have changed things but it has not stopped us. We continue to hold our weekly Morning Program on-line, showcasing our learning and student accomplishments. We have continued to hold classroom holiday celebrations, but in new ways. We will be participating in the OCRRA Earth Day Clean-up on April 24 and have begun to bring in special guests using online technologies.

The Rockwell building renovations began in March. Each of our classrooms are being updated with new handicapped accessible bathrooms, cubbies and cabinetry. The nurse's and social worker offices are being enlarged and updated. It will be wonderful to come back in September to newly renovated classrooms and building.

Everyone in the Onondaga Central School District Community should be so proud of all the accomplishments of the students, staff, and administration. We have found our way to successfully educate our children during this pandemic. We at Rockwell School thank the community for all the support you have given and shown us during this different school year. It is truly appreciated!



Also, school board costs, curriculum development, tax collection, legal and auditing costs, central printing, central data processing and BOCES administrative costs.
- 2. Program costs include the salaries and benefits of all teachers and staff delivering pupil services (health, guidance, library, and athletics). Also, textbooks, instructional materials, equipment, extracurricular student activities, BOCES program costs, and all costs of the transportation program except bus purchases.
- **3. Capital costs** include the salaries and benefits of maintenance and custodial staff, plus debt service, utilities, and general insurance.



### **BOARD Advocacy and Strategic Goals:**

The Onondaga CSD Board of Education supports the below strategic goals that were adopted in 2014-2015. The strategic goals set the framework of the service provided by the board both at the local level and at the state level.



### **Contingent Budgets**

If residents vote down the proposed budget, the Board of Education has two options:

- Resubmit the same budget or a revised budget for a revote on June 15.
- Adopt a contingent budget, which state law now dictates cannot exceed the current year's tax levy. (If residents vote down a resubmitted budget, the district MUST adopt a contingent budget.)

What's a contingent budget? Unlike in years past, the new statute requires contingent budgets to carry a ZERO percent increase over the current year's levy. In other words, the district would have to levy the same amount of taxes as in the current year or less – without any adjustment for state pension rate increases, contractual obligations or any other costs, mandated or not. It also means all "non-contingent expenses" would have to be cut from the budget. These include field trips for social or entertainment purposes, new equipment, non-essential maintenance spending and some student supplies.

### **BOARD OF EDUCATION CANDIDATES:** VOTE FOR TWO (2)

The two candidates receiving the highest number of votes each will be elected to three-year terms commencing July 1, 2021, and ending on June 30, 2024.

### PROPOSITION I - (Budget)

Shall the proposed budget of the Onondaga Central School District as recommended by the Board of Education for the fiscal year beginning July 1, 2021 in the sum of \$23,190,109 (Twenty-Three Million, One Hundred Ninety Thousand, One Hundred Nine Dollars) as a general fund appropriation be adopted and shall the Board of Education be authorized to levy the necessary taxes therefor?

### PROPOSITION II - (Student Transport Vehicles)

Shall the Board of Education purchase and, at the option of the Board, finance two (2) student transportation vehicles at an estimated cost not to exceed \$274,212.50, including necessary furnishings, fixtures and equipment and all other necessary costs incidental thereto and to expend a total sum not to exceed \$274,212.50, which is estimated to be the total maximum cost thereof, and shall the Board be authorized, at its option, to finance such purchase or so much thereof as may be necessary by levying a tax upon the taxable property of the District, which is hereby voted for the foregoing in the amount of \$274,212.50, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board and in anticipation of the collection of such tax, shall bonds or notes be authorized to be issued or executed at one time, or from time to time, in the principal amount not to exceed \$274,212.50 and shall a tax be authorized to pay the interest on said obligations when due?

### PROPOSITION III - (Library)

Shall the Onondaga Central School District Levy and collect a tax, pursuant to section 259 of the Education Law of the state of New York for the benefit of the Onondaga Free Library, in the sum of \$56,650 (an increase of \$1,650 from the levy of 2020-2021 which was the sum of \$55,000) for the continuing support and maintenance of the Free Library services offered to the district residents?
