#### What is ARPA? American Rescue Plan Act

ARPA is an emergency legislative package to fund schools

#### How will ARPA help K-12 public education?

Federal funding is intended to boost American schools, allotting \$125 billion to K-12 school districts and state education departments. Most of the money is intended to address learning loss suffered by students during pandemic-induced school closures. Additionally, this money could be transformational in re-inventing schooling to ensure that students, especially those traditionally left behind, are provided with the teachers and tools they need to be successful. Within this presentation, you will view how the Onondaga Central School District plans to utilize the ARPA funding.



#### **ARPA Requirements**

- 3 Years (2021-2022 through 2023-2024)
- Stakeholder input and public comment required
- Plan must be posted on the district website by July 1, 2021
- Updated plan by July 1, 2022
- Federal money is to be used to supplement district programing, not supplant
- \$2,084,213 total allocated to the district
  - \$1,384,213 ESSER 3 (Elementary and Secondary School Emergency Relief Fund)
    - At least 20% (\$276,843) to address learning loss
    - Remaining 80% (\$1,107,370) to address other district needs
  - \$700,000 State Level-Reserve Reserve (Learning Loss Grant)
    - At least 15% (\$100,002) on evidence based summer enrichment
    - At least 15% (\$100,002) on evidence based afterschool enrichment
    - Remaining 70% (\$499,996) on other needs (evidence based)

## **Rockwell Elementary Programs**

#### **Target students:**

- Students Kindergarten through Second Grade
- Students in need extra help in a specific subject area
  - Based on AIMS web scores
  - Fountas and Pinnell Reading Level
  - Classroom Observation
  - Social/Emotional Needs
  - Articulation concerns
- Students seeking enrichment activities to build social skills
- Students who were remote for 2020-2021



## **Rockwell Elementary Highlights**

- Held four sessions; 2 in the fall and 2 in the spring, 4-6 weeks long
- Offered ELA, Math and Speech for each grade level
  - 2 days a week
  - Monday and Wednesday
- Offered Cheerleading and gymnastics, Fit Kids, Drama, Art Club, Ballet, Exploring Nature, Kindness in our Community, Cooperative Games, Physical Fitness Fun, Coding and Games, and Super Science
  - 2 days a week
  - Tuesday and Thursday
- Transportation provided
- Positive responses from parents survey



## Wheeler Elementary Highlights

- Held four sessions; 2 in the fall and 2 in the spring, 4-6 weeks long
- Offered ELA, Math, and Science related activities for different grade levels
  - 2 days a week
  - Tuesday and Thursday
- Offered Collaborative games, bird watching, drama workshops, Art Club, Crocheting, Outdoor Games, and an Author in Residence program
  - 2 days a week
  - Monday and Wednesday
- Transportation provided
- Positive responses from parents and students



## Wheeler Elementary Programs

- Students Third Grade through 6th Grade
- Students in need extra help in a specific subject area
  - Based on AIMSweb scores
  - NYS Test Scores
  - $\circ$  Classroom Observation
  - Social/Emotional Needs
- Students seeking enrichment activities to build social skills
- Students who were remote for 2020-2021



## Jr/Sr High School Enrichment

• Core Subject Areas 3:00-5:15 pm for Marking Periods 4-6

#### Target students:

- Students 7th-12th Grade
- Students who are failing subject area class
- Students who failed 1st semester class
- Students seeking extra help in a specific subject area
- Students seeking enrichment activities
- Students who were in person learning 90 out of 180 days in 2020-2021
- Students who were remote for 2020-2021
- Students who are placed on an AIP/TIP



## Jr/Sr High School Objectives

**Objective (s) to support learning loss:** 

- Students will be able to successfully complete the tasks needed to be successful in the course, local summative exam and/or NYS State Regents.
- Students will be able to familiarize themselves with the structure of the Regents Exams for June.
- Students will work towards mastery with content they missed or failed during the first 3 marking periods
- Students will be able to familiarize themselves with the structure of the Summative Exams for successful completion of the course
- Students will complete project based assignments related to the course
- Students will be able to utilize subject specific skills as well as comprehension strategies.
- Students will be able to effectively outline strategies to complete tasks related to the course.
- Students will be able to effectively understand the objectives of the course and complete tasks to effectively complete the course.
- Students will hopefully reach or exceed individual goals set at the beginning of the program not only with practice exams, but on the Final/Regents exam.
