Foundation Aid

- School districts will receive the larger of:

- Half of Foundation Aid still due (364 districts)
- A 3% increase over 2021-2022 Foundation Aid (309 districts)

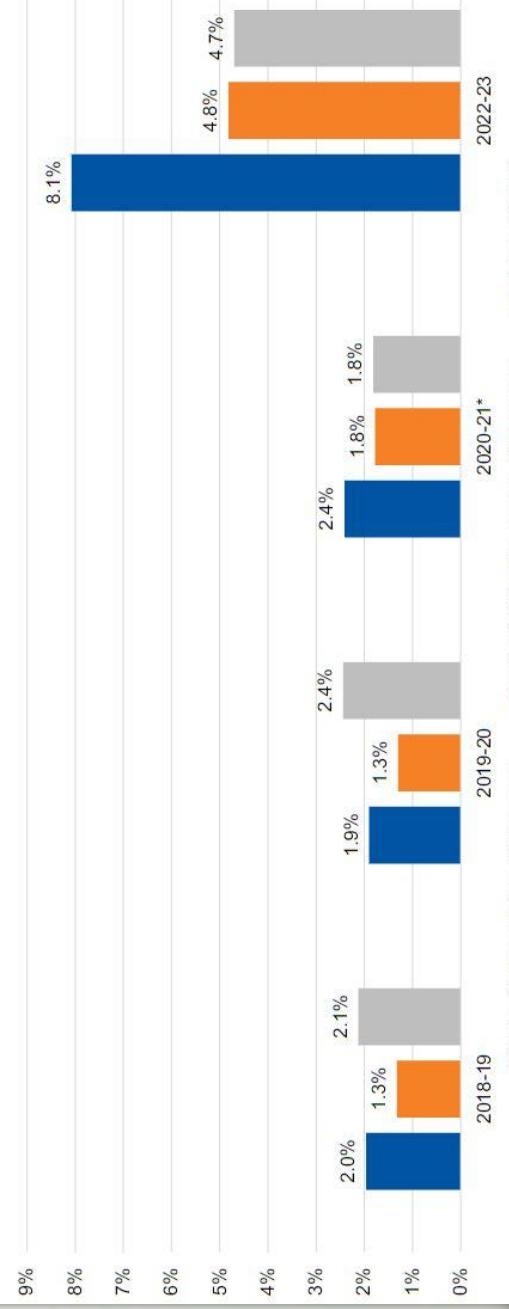
Foundation Aid Phase-in

- 2021-22 Enacted budget includes 3-year path to fully fund Foundation Aid
- 10/2021: NYSER Settlement
 - NY State agreed to a full Foundation Aid phase-in by 2023-24

Electric School Buses

- **Original proposal from the Executive Budget:**

- All school bus purchases must be zero-emission by 2027 and that all school buses on the road be zero-emission by 2035
- Electric buses, electricity for school buses, and charging stations are eligible for transportation aid
- School districts can enter 10-year leases for electric buses
- Not included in Executive Budget proposal: funding, waiver process, technical assistance

Questions:

- Currently - electric buses 3x cost
- Even with state aid + (~40%)
- Infrastructure upgrades?
- Personnel concerns?
- Supply concerns - annual replacement of ~5,000 buses?
- Range issues? OCS has buses that travel 200 miles daily



Enacted NYS Budget - Electric School Buses

- Districts can apply for 2-year initial waiver (through 2029)
 - Can't layoff workers, provided employees agree to be retrained
 - Districts will have to create a "Workforce Development Plan" that estimates:
 - positions eliminated/ substantially changed
 - jobs created
 - identifies skills-gaps
 - Maximum lease terms = 12yrs (currently 5yrs)
 - \$500mil in Environmental Bond Act (on Nov Ballot)
 - "Made in USA Requirement"
- *there will be "additional discussion" (much of this is subject to additional alterations)**
- *this will substantially add to school districts' burden**
- *upcoming webinars in future**

Enacted NYS Budget - UPK

- Expansion of pre-k for 4-year-olds (\$125mil)
- 336 districts receiving funding
 - including 29 districts without state-funded pre-k program
- OCS's "allocation" assumes expanded UPK program.
 - Currently, the District does not have capacity in 2022-23
 - Additional space/staffing would be required

Enacted NYS Budget - Retiree Income Cap

- Temporarily waives the \$35,000 retirement income cap for school employees
 - Allows recently retired individuals to return to employment in a public school or BOCES without any suspension or reduction in their pension payment
 - In effect until 6/30/2023 - after which the cap will apply

Enacted NYS Budget - Property Tax Rebate Credit

- Homeowners enrolled in STAR who had qualified gross income less than \$250,000 in the 2022 tax year
- Rebate is equal to between 18%-163% of basic STAR benefit depending on qualified gross income, 66% of enhanced STAR benefit

Video Conferencing for School Board Meetings

- School boards are now permitted to meet virtually
 - The public must be given the opportunity to attend, listen and observe meetings in at least one physical location at which a board member is participating
 - Absence must be for allowable reason
 - The board may use video conferencing to conduct meetings provided that the minimum numbers of members to fulfil quorum requirements are in a location where the public can attend

Policies NOT Included in the Enacted Budget

- Raising BOCES CTE salary cap
- Increasing the Capital Outlay Exception
- Funding for Prior Year Adjustments
- Repeal of state transparency reporting

State Aid for OCS

2022-2023 Increase in Aid of \$988,180 or 9.4%.

This “extra” increase is due the Governor’s proposal to fully fund Foundation Aid and additional BOCES Aid

Historical Comparison:

2016-17: \$694,351 or 7.65%

2017-18: \$93,041 or 1.8%

2018-19: \$74,717 or 1.4%

2019-20: \$699,570 or 7.08%

2020-21: \$288,624 or 2.73%

2021-22: \$463,548 or 3.82%

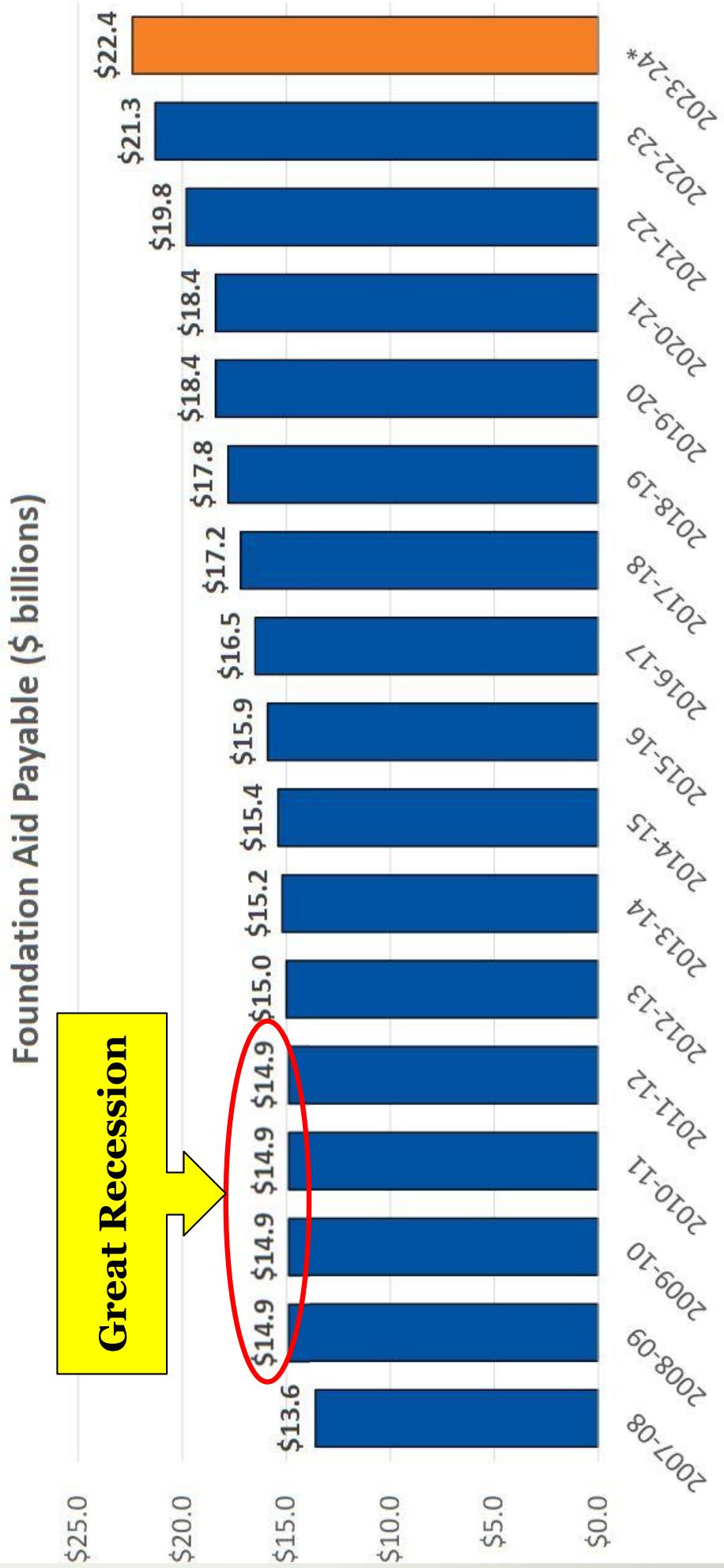
